RULES AND REGULATIONS

1. PARTICIPATION:

- e. Participants must also submit a short bio- data mentioning their full name, college name, contact number, email and postal address.

2. Presentation:

- a. The research article must comprise of not less than 7500 words and not more 10000 words including footnotes.
- b. The following content specifications shall be strictly adhered to:
 - i. The research article should be typed on A4 size paper.
 - ii. Body Font and Size: Times New Roman, 12.
 - iii. Line Spacing: Double Space.
 - iv. Footnotes Font and Size: Times New Roman, 10.
 - v. Line Spacing: 1.0.
 - vi. Alignment (Body & Footnotes): Justified.
 - vii. Margin: 1 inch on all 4 sides.
 - viii. Citation Method: The Bluebook, A Uniform System of Citation, Harvard Law Review, 20th edition.
- c. A separate page for bibliography indicating all the articles, books, references, websites etc. referred to, should be added at the end of the article.
- d. Participants must email a copy of their entry as an MS Word document and as a PDF to krramamani2022@gmail.com on or before 1st March, 2022 by 23:59 hours.
- e. The subject of the mail shall be "Entries for VSS Research Paper".
