RULES AND REGULATIONS

1. PARTICIPATION:

- a. **NO REGISTRATION FEES** is required to be paid for the V.S. Sundaram Memorial Research Paper Competition.
- b. An article can be authored by a maximum of two students.
- c. Entries must be in English only.
- d. Participation is restricted to students enrolled in undergraduate courses in Law, Accountancy, Commerce and Taxation.
- e. Participants must also submit a short bio- data mentioning their full name, college name, contact number, email and postal address.

2. PRESENTATION:

- a. The research article must comprise of not less than 7500 words and not more than 10000 words including footnotes.
 - b. The following content specifications shall be strictly adhered to:
 - ❖ The research article should be typed on A4 size paper.
 - ❖ Body Font and Size: Times New Roman, 12.
 - ❖ Line Spacing: DoubleSpace.
 - ❖ Footnotes Font and Size: Times New Roman, 10.
 - ❖ Line Spacing: 1.0.
 - ❖ Alignment (Body & Footnotes): Justified.
 - ❖ Margin: 1 inch on all 4sides.
 - ❖ Citation Method: The Bluebook, A Uniform System of Citation, Harvard Law Review, 20th edition.
 - c. A separate page for bibliography indicating all the articles, books, references, websites etc. referred to, should be added at the end of the article.
 - d. Participants must email a copy of their entry as an MS Word document and as a PDF to krramamani2023@gmail.com on or before **1st March, 2023 by 23:59 Hours**.
 - e. The subject of the mail shall be “**Entries for VSS Research Paper**”.

- a. Each research article will be marked for a total of 100 marks.
- b. The criteria for judging and the weightage given to every judging criterion are reproduced in the table below:
